In requesting participation, I understand that NAMLS will issue one "Agent ID" number and Password to me for my use as a non-licensed Administrative Member User. **The Agent ID number and Password is provided exclusively for the use of the user and may not be shared with or used by any other person.** Access to NAMLS can be terminated by either written instruction of the MLS Participant (Designated Broker) upon termination of employment OR if it becomes known that the Administrative Member has violated the SVVAR Bylaws, the MLS Rules and Regulations and/or the MLS Operating Policies. Upon termination of employment, I understand my ID and Password will be inactivated.

All data and photos submitted to NAMLS becomes the property of the Northern Arizona Multiple Listing Service. As a user, I agree to utilize all data received by NAMLS in accordance with the MLS Rules and Regulations and the MLS Operating Policies.
